This Feel and See Guarantee is valid for a period of 30 days from the date of purchase and can only be claimed from authorized Clarisonic kiosks and retailers where the device was originally purchased. Proof of purchase is required and the product must be returned in its original packaging with all the components. Please note that this Feel and See Guarantee does not apply to Clarisonic devices purchased from the travel retail channels.

Clarisonic Limited Warranty for Malaysia

1. Warranty Coverage

- a) For the duration of the Warranty Period, Clarisonic warrants the Product against defects in materials and workmanship arising from Normal Use of the Product.
- b) If there is a defect in the Product which is covered by this Warranty, Clarisonic agrees to exchange the Product with a new equivalent Product. Clarisonic’s sole obligation under this Warranty is limited to such replacement.

2. How to get Warranty Service

3. Conditions and Exclusions

- a) This Warranty is limited and may be relied upon only:
 - (i) by an end user of the Clarisonic Product;
 - (ii) within the Warranty Period;
 - (iii) where the Product was manufactured by or for Clarisonic and sold by an authorized distributor.
- b) To obtain service under this Warranty, you will be required to provide Clarisonic with original proof of purchase.
- d) This Warranty does not apply where the Product is subjected to use that does not constitute Normal Use, including but not limited to personal injury or property damage arising from misuse of the Product.

4. Exclusions

Clarisonic is not responsible for any indirect, incidental or consequential damages arising out of the use of the Product, whether arising from an electrical issue or otherwise.

5. Definitions

- a) “Normal Use” means ordinary consumer use under normal home conditions and used in accordance with the instruction manual included with the Product. It does not include use of the Product with a voltage converter, negligent use or misuse.

b) "Product" means Clarisonic Mia 1, Mia 2, Aria, Pedi, Smart Profile, Alpha Fit, or Mia Fit.

c) Warranty Period" means:

- 1 year for Clarisonic Mia 1
- 2 years for Clarisonic Mia 2, Aria, Pedi, Smart Profile, Alpha Fit and Mia Fit from the date of purchase of the Product.

6. Validity

This Warranty is valid only in respect of purchases made with authorized Clarisonic Kiosks & Retailers and all disputes arising from the purchase of the Product or the interpretation of this Warranty shall be governed by **Malaysia** law.
