COMPLAINT FOR PATENT
INFRINGEMENT

JURY DEMAND

Plaintiff Pacific Bioscience Laboratories, Inc. (“PBL”), for its Complaint for Patent Infringement against Defendant ANEX Corporation, (“ANEX”), hereby alleges, by and through its attorney, on personal knowledge as to its own actions and on information and belief as to the actions of others, as follows:

I. INTRODUCTION

1. Plaintiff PBL dramatically changed the market for skin cleansing products when it introduced its innovative Clarisonic Sonic Skin Cleansing System (the “Clarisonic System”) in 2004. The Clarisonic System employs motion and forces at sonic frequencies to cleanse, soften, and smooth skin.

1 2. Prior to the introduction of the Clarisonic System, there were no sonic facial
2 cleansing devices on the market. PBL created today's market for such products.
3

4 3. The Clarisonic System has been an enormous success and has achieved national
5 recognition and awards. In 2010, PBL was named one of Inc. 500's Fastest Growing Private
6
7 Companies.
8
9

10 4. PBL received broad protection for its innovations, including utility and design
11 patents. However, PBL's innovations have been the subject of widespread imitation by others,
12
13 who have attempted to capitalize on PBL's success.
14
15

16 5. Defendant ANEX is one such imitator. After seeing PBL's success, ANEX
17 introduced its Mimian facial cleansing system ("Mimian"). ANEX has made the Mimian work
18
19 and look like PBL's products, thereby infringing PBL's patents.
20
21

22 6. ANEX sells or has sold the Mimian throughout the United States through, at least,
23 Amazon.com, [http://www.amazon.com/Mimian-Beauty-Portable-Cleanser-](http://www.amazon.com/Mimian-Beauty-Portable-Cleanser-Facial/dp/B00JSQ5ZG6/)
24

28 7. PBL seeks to stop ANEX's infringing conduct and obtain compensation for the
29
30 violations that have occurred thus far.
31

32 II. PARTIES

33 8. Plaintiff PBL is a Washington corporation incorporated in January 2001, with its
34
35 principal place of business at 17275 NE 67th Court, Redmond, WA 98052.
36
37

38 9. In December 2011, PBL was acquired by L'Oréal S.A., a French société anonyme
39
40 ("L'Oréal"). L'Oréal is the owner, and PBL is the exclusive U.S. licensee with the right, inter
41
42 alia, to bring suit, of protectable patent rights as described herein.
43

44 10. On information and belief, ANEX Corporation is a corporation organized and
45
46 existing under the laws of Korea with its principal place of business at C-304 Seoul Hightech
47
48 Venture Center, 647-26 Deungchon-dong, Gangseo-ku, Seoul, 157-030, Korea. On information
49
50
51

1 and belief, ANEX also has a place of business at #304-705 Bucheon Techno Park, 345
2
3 Seokcheon-ro, Ojeong-gu, Bucheon City, Gyenggi-do 421-741, Korea.

4
5 11. On information and belief, ANEX manufactures, markets, and sells electric skin
6
7 care devices under the name Mimian.

8
9 **III. JURISDICTION AND VENUE**

10
11 12. This case arises under the patent laws of the United States, 35 U.S.C. § 101 et seq.

12
13 13. The Court has subject matter jurisdiction over this case pursuant to 28 U.S.C.
14
15 §§ 1331, 1332, and 1338.

16
17 14. PBL has its principal place of business in this District, and makes its Clarisonic
18
19 devices available for sale in this District.

20
21 15. This Court has personal jurisdiction over ANEX because, on information and
22
23 belief, ANEX has committed and continues to commit the acts violating PBL's intellectual
24
25 property described herein within the State of Washington, including in this District, and places
26
27 infringing products into the stream of commerce, with the knowledge or understanding that such
28
29 products are sold in the State of Washington, including in this District.

30
31 16. Venue is proper in this District pursuant to 28 U.S.C. § 1391(b), (c), and 28
32
33 U.S.C. § 1400(b) because, *inter alia*, PBL's principal place of business is within this District and
34
35 PBL suffered harm in this District, because a substantial part of the events giving rise to the
36
37 claims against ANEX occurred and are occurring in this District, and because ANEX transacts
38
39 business within this District and offers for sale in this District products that infringe PBL's
40
41 intellectual property.

42
43 **IV. BACKGROUND**

44
45 17. Since the early 2000s, PBL has designed, developed, manufactured, marketed,
46
47 and sold in the United States (and worldwide) its innovative Clarisonic System, which is a line of
48
49 skin care products including a number of Sonic Cleansing Brushes and accessories, the
50
51

1 Clarisonic Opal® Sonic Infusion System, and targeted treatment solutions. Examples of
2
3 Clarisonic products are pictured below:

21 18. The Clarisonic System was developed by PBL over many years at great expense
22 and effort and represents a breakthrough in devices and methods for treatment of early stage acne
23 and for effective cleansing of skin. Those devices and methods employ motion and forces at
24 sonic frequencies to cleanse, soften, and smooth skin. They alleviate clogged pores and remove
25 debris from skin more gently and effectively than alternative devices or methods, such as manual
26 cleansing.
27
28
29
30
31

32
33 19. The innovations embodied in the Clarisonic System are protected by numerous
34 United States and foreign intellectual property rights, including rights deriving from patents.
35

36
37 20. Prior to the introduction of the Clarisonic System, there were no sonic facial
38 cleansing devices on the market. Indeed, before development of the Clarisonic System, no
39 market existed for sonic skin care devices. PBL expended considerable resources to create the
40 sonic skin care market and to educate the public regarding facial cleansing, as well as to market
41 its sonic facial cleansing devices.
42

46
47 21. Since its introduction, the Clarisonic System has become widely acclaimed by
48 professionals and consumers, and has garnered many media awards from sources such as
49 authoritative magazines in the beauty industry, Oprah's Favorite Things in 2007 on the Oprah
50
51

1 Winfrey Show, Best of Sephora in 2007 and 2008, and QVC Customer Choice in 2008, 2009,
2 and 2010.
3

4 22. The success of the Clarisonic System has spurred a large number of imitations,
5 such as ANEX's Mimian, pictured below.

V. PBL'S PATENTS

32 23. U.S. Patent No. 7,320,691 ("the '691 patent") issued on January 22, 2008, and is
33 entitled "Apparatus and Method for Acoustic/Mechanical Treatment of Early Stage Acne." The
34 inventors are Kenneth A. Pilcher, David Giuliani, and Stephen M. Meginniss.

37 24. A copy of the '691 patent is attached as Exhibit 1.

39 25. PBL is the exclusive licensee having all substantial rights in and to the '691
40 patent, with the rights to bring enforcement actions for past, present and future infringement and
41 to collect damages for past infringement.

45 26. The '691 patent has been reexamined pursuant to Reexamination Request Nos.
46 90/009,797 and 90/011,343. The patentability of all of the originally issued claims 1-52 of the
47

1 '691 patent was confirmed pursuant to these reexamination requests, and claims 53-64 were
2 added. A reexamination certificate issued on September 20, 2011. *See* Exhibit 1.
3

4 27. The '691 patent is valid, enforceable, and currently in full force and effect.
5

7 **U.S. Patent No. 7,386,906**
8

9 28. U.S. Patent No. 7,386,906 (“the '906 patent”) issued on June 17, 2008, and is
10 entitled “Oscillating Brushhead Attachment System for a Personal Care Appliance.” The
11 inventors are Dane M. Roth, Stephen M. Meginniss, III, Kenneth A. Pilcher, Richard A. Reishus,
12 and David Giuliani.
13
14

15 29. A copy of the '906 patent is attached as Exhibit 2.

18 30. PBL is the exclusive licensee having all substantial rights in and to the '906
19 patent, with the rights to bring enforcement actions for past, present and future infringement and
20 to collect damages for past infringement.

23 31. The '906 patent is valid, enforceable, and currently in full force and effect.

45 35. ANEX's infringement of the '691 patent has been and will continue to be willful
46 and deliberate, by making, using, offering to sell, and/or selling in the United States and/or

4 36. ANEX's infringement of the '691 patent has caused and will continue to cause

5 **VI. DEMAND FOR JURY TRIAL**

7 42. Pursuant to Rule 38 of the Federal Rules of Civil Procedure, PBL respectfully
8 requests a trial by jury of all issues properly triable by jury.

11 **VII. PRAYER FOR RELIEF**

12 WHEREFORE, PBL prays for relief, as follows:

- 13
14 A. A judgment that ANEX has infringed one or more claims of the '691 patent;
15
16 B. A judgment that ANEX has infringed one or more claims of the '906 patent;
17
18 C. An order and judgment preliminarily and permanently enjoining ANEX and its
19 officers, directors, agents, servants, employees, affiliates, attorneys, and all others acting in
20 privity or in concert with them, and their investors, partners, parents, subsidiaries, divisions,
21 successors, and assigns, from further acts of infringement of PBL's asserted patents;
22
23 D. A judgment awarding PBL all damages adequate to compensate for ANEX's
24 infringement of PBL's asserted patents, and in no event less than a reasonable royalty for
25 ANEX's acts of infringement, including all pre-judgment and post-judgment interest at the
26 maximum rate permitted by law;
27
28 E. A judgment declaring that ANEX's infringement of the asserted patents has been
29 willful and deliberate;
30
31 F. A judgment awarding PBL all damages, including treble damages, as a result of
32 ANEX's willful and deliberate infringement of the asserted patents, pursuant to 35 U.S.C. § 284,
33 together with pre-judgment and post-judgment interest;
34
35 G. A judgment declaring that this case is exceptional and awarding PBL its expenses,
36 costs, and attorney's fees in accordance with 35 U.S.C. §§ 284 and 285 and Rule 54(d) of the
37 Federal Rules of Civil Procedure; and
38
39 H. Such other and further relief as the Court deems just and proper.
